**Temporary Special Event License
Application**

Only a bona fide Non-Profit Civic Organization may apply for this permit.

A temporary special event alcohol permit may be issued to any non-profit civic organization for an approved special event. The non-profit organization must make application and pay the fee that may be required by the Ordinance and shall be required to comply with all the general provisions of Ordinance and the licensing and regulations for a consumption on the premises establishment, with the exception of the full-service kitchen requirement.

Special Requirements for Bona Fide Non-Profit Civic Organizations:

- Department of Revenue Permit
- Verification of organization's current non-profit status (a bona fide non-profit civic organization is one which is exempt from federal income tax, pursuant to the provisions subsections (c), (d) or (e) of 26 U.S. C. Section 501.)

- No more than six (6) permits for a maximum of two (2) days at a time in any one calendar year.
- All events must be associated with and benefit the cause of the non-profit.
- The event must receive approval from law enforcement on crowd control, parking and security measures.
- The location of the event must be approved in writing by owner of the property.
- As a condition of the issuance of a temporary special event license, the licensee shall indemnify and hold the City of Blairsville harmless from any claims, demands or causes of action which may arise from activities associated with the special event.
- The requirements of an eating establishment, number of seats, and percentage of sales shall not apply to a temporary special events license.
