

**CITY OF BLAIRSVILLE, GEORGIA**

**RESOLUTION No.**

**WHEREAS**, the City Council has adopted an ordinance to regulate the sale of alcoholic beverages that provides for fees to be set for certain licenses, permits, investigations, and applications; and

**WHEREAS**, the City Council wishes to set a schedule of fair and comprehensive fees pertaining to the sale of alcoholic beverages;

**NOW THEREFORE**, the Mayor and City Council hereby adopt the following license fee schedule, which shall apply to all fees pertaining to the ordinance to regulate the sale of alcoholic beverages:

**\*NOTES:**

**1. ANY ESTABLISHMENT WHICH HAS BEEN IN BUSINESS IN THE CITY OF BLAIRSVILLE FOR TWO YEARS OR MORE IMMEDIATELY PRIOR TO THE DATE OF APPLICATION, AND HAS BEEN UNDER THE SAME OWNER FOR THAT TWO YEAR PERIOD, MAY PAY THE INITIAL LICENSE FEE OR FEES IN TWO INSTALLMENTS. ONE**

**HALF SHALL BE PAID UPON APPLICATION AND ONE HALF NO LATER THAN SIX (6) MONTHS FROM THE DATE THE LICENSE IS GRANTED.**

**2. FOR ALL INITIAL LICENSES ISSUED AFTER JULY 1 IN ANY YEAR, THE ANNUAL RENEWAL FEE DUE BY THE END OF THAT YEAR FOR THE FOLLOWING YEAR SHALL BE ONE HALF (1/2) OF THE REGULAR RENEWAL FEE. THE FULL FEE WILL BE DUE EVERY YEAR THEREAFTER.**

**3. IF AN APPLICANT WITHDRAWS ITS APPLICATION BEFORE A LICENSE IS ISSUED, ANY LICENSE FEE PAID WILL BE REFUNDED, BUT ALL OTHER FEES WILL BE RETAINED.**

**4. ANY LICENSE GRANTED IN 2010 SHALL BE VALID UNTIL JANUARY 1, 2012 WITHOUT FURTHER PAYMENT OF A RENEWAL FEE FOR 2011.**
